RULES + GUIDELINES

The following have been established to ensure that everyone's stay at Valaqua is a happy one.

- Everyone on camp property must comply with all posted regulations.
- Camp Valaqua is a Christian camp. We expect everyone to act in keeping with Christian values of love and respect for others.
- Illegal drugs and alcohol are not permitted on camp property.
- 4. Smoking is permitted only in the designated outdoor smoking area.
- Fires are not permitted in cabins unless an adult is staying in the cabin. Candles are not permitted in the cabins.
- Fires may only be built in designated firepit areas and must be completely extinguished before left unattended. Local fire restrictions are to be followed.
- 7. All vehicles must be parked in the parking lot.
- 8. Picking/destruction of plants, flowers, trees, etc is prohibited.
- We discourage the bringing of pets to camp.Pets are not allowed in any buildings.
- 10. Noise should be restricted after 11PM.
- Use of Activity areas must be booked in advance and will depend on staff availability and weather.
- 12. Off-road vehicles are not permitted.
- 13. All groups must have at least 1 adult (age 18+) for every 6 children. Children must be adequately supervised at all times.
